CASE CONSULTATION

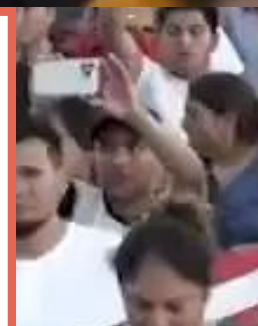
We provide expert case consultation, training, and resources to attorneys and advocates navigating the complex immigration system on behalf of survivors of gender-based violence, including intervening in specific cases as needed.

POLICY

We push for federal, state and local policies that ensure safety and justice for immigrant survivors.

LITIGATION

We coordinate lawsuits to prevent the government from unfairly deporting survivors of violence.





For almost 2 years, Jada* suffered severe abuse by her US citizen husband. When she finally broke free, her attorney filed a petition under the Violence Against Women Act for Jada to become a permanent resident. After almost three and a half years of delays, Jada's attorney contacted ASISTA for help... and less than 10 days later, reported, **"Jada's petition was APPROVED! Clearly, that was the result of your intervention. I can't thank ASISTA enough for your advocacy work!"** Now Jada can start working and reuniting with her children, whom she hasn't seen in years.

Changing Lives

When Elena* tried to leave her abusive, US citizen husband, he contacted ICE to try and deport her. Because of him, when Elena was just about to become a permanent resident of the US, ICE instead arrested her. Elena's attorney contacted ASISTA for help, and later said, **"I am eternally grateful to ASISTA. My client literally would not be here if it weren't for you!"** We are delighted to share that Elena is now a permanent resident of the US, providing for herself and her US citizen children in a home free of violence.

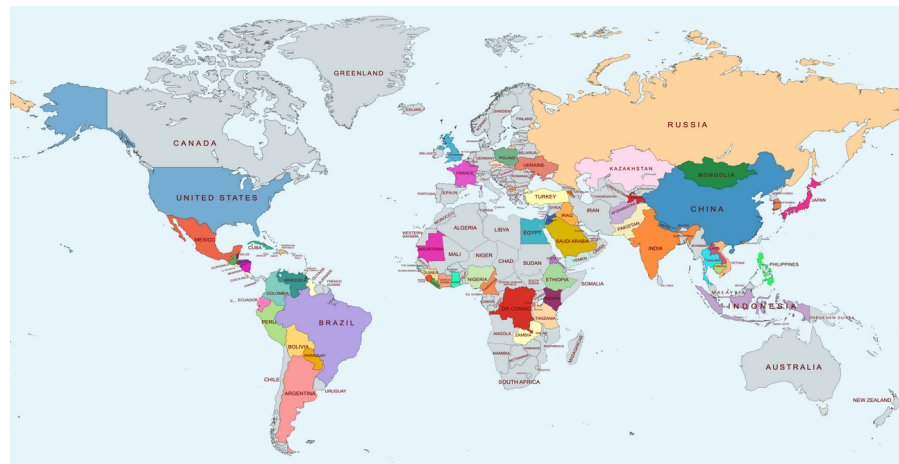
